- ii. Independent Software Vendors ("ISVs")
- iii. Information Vendors ("IVs")

to the Bursa Trade Securities 2(BTS2) Certification environment.

## Getting connected to the "Cert" environment

2.1. POs/ISVs/IVs can provide their request for information by sending a letter/email request to the following:

- 2.3. Please fill in the form BTS2-A1 Form, which is found in the document titled "FIX Certification Environment VPN Connection Guide" and submit to Bursa Malaysia.
- 2.4. Bursa Malaysia will provide the following within 5 working days:
  - a) Connectivity details
  - b) Access (FIX) ID
- 2.5. POs/ISVs/IVs will be responsible for the connectivity setup to the Certification environment. Please refer to the network connection guide document, "FIX Certification Environment VPN Connection Guide" for more information.
- 2.6. After connectivity has been set up, POs/ISVs/IVs must test the connectivity (with IPs and port numbers) to the Cert environment.





Figure 1 - Onboarding Process Flow

Please submit the FIX certification test logs in the format provided, which is found in the document titled "FIX Certification Test Logs" and submit to Bursa Malaysia.

### 5. Environment Guidelines

- POs/ISVs/IVs must request formally by filling up Form BTS2-A1 and DECLARTION Form to On-Board to Certification Environment access into the Certification Environment. The BTS2-A1 can found in the "FIX Certification Environment VPN Connection Guide" document.
- 2. Bursa Malaysia provides the accessibility to the Bursa Malaysia Certification environment via the following means
  - a. Co-Location at Bursa
  - b. Internet IPSec VPN
- 3. The availability of Certification environment is subject to the number of network ports and Access (FIX) IDs available at that point of time.
- 4. The Trading sessions in the Certification environment[Monday to Friday] are as follows:

Please note that this may change from time to time depending on the activities that are conducted by the Exchange itself.

- The provision of access into the Bursa Certification selection will be based on a first-comefirst-serve basis and availability of the Certification facility.
- 6. Bursa Malaysia reserves the right to reject, reschedule or limit the requests.
- 7. Bursa Malaysia reserves the right to reject any request if POs/ISVs/IVs breach any of the Bursa Malaysia Policies.
- 8. Bursa Malaysia will provide the necessary network configuration and the POs/ISVs/IVs are expected to configure the test servers accordingly. The POs/ISVs/IVs are required to use



the assigned network configuration and use the information for that purpose only.

- 9. POs/ISVs/IVs are not allowed to do any performance testing on the Certification environment without permission from Bursa Malaysia.
- 10. FIX connectivity testing will be required for new connections to ensure that the Access (FIX) IDs and passwords have been configured correctly.
