- (1) **BURSA MALAYSIA SECURITIES BERHAD MAIN MARKET LISTING REQUIREMENTS ("Main LR")**

We refer to our letter dated 8 May 2009 in relation to the Main LR.

(1) ***Main LR amendments***

Please note that pursuant to section 9 of the Capital Markets and Services Act 2007, Bursa Malaysia Securities Berhad ("**Bursa Securities**") has amended the Main LR.

The amendments to the Main LR are aimed at providing greater clarity and facilitating compliance by listed issuers. The key changes include the following:

- (a) clarifying the valuation requirements in relation to transactions which involve acquisitions or disposals of real estate;
- (b) clarifying the minimum contents of quarterly reports of a real estate investment trust and exchange traded fund; and
- (c) allowing share buy-back by a SPAC for the purpose of the SPAC paying to its voting securities holders who voted against the qualifying acquisition the requisite amount as required under the Main LR.

For ease of reference, the amendments made are reflected in the following manner:

- portions underlined are text newly inserted/added/replaced onto the existing rules; and
- portions struck through are text deleted.

The full text of the amended Chapters and Practice Notes of the Main LR (with the amendments tracked) is attached for your reference. The unmarked copy of the amended Main LR is also available at our website at <http://www.bursamalaysia.com>. The Chapters and Practice Notes of the Main LR which have not been attached to this letter remain unchanged.

The amended provisions will take effect from **3 August 2009**.

(2) ***Questions & Answers***

Following the technical briefings organised by Bursa Securities for listed issuers on the Main LR which were held on 18 June 2009 and 6 July 2009 respectively, we have also compiled additional Questions & Answers to address issues commonly raised on the Main LR during the said technical briefings for your reference. We hope the Questions & Answers will facilitate and aid listed issuers' compliance with and understanding of the Main LR.
