CLARIFICATION ON IMPLEMENTATION DATES OF THE AMENDMENTS TO THE ACE MARKET LISTING REQUIREMENTS ("ACE LR") IN RELATION TO DIRECTOR APPOINTMENT, INDEPENDENCE AND MISCELLANEOUS CHANGES ("ENHANCED DIRECTOR AMENDMENTS & MISCELLANEOUS CHANGES")

1. We refer to our letter dated 19 January 2022 in relation to the Enhanced Director Amendments & Miscellaneous Changes ("the said letter")¹.

Clarification on implementation dates

- 2. The Exchange has received enquiries regarding the implementation dates of the Enhanced Director Amendments & Miscellaneous Changes.
- 3. In view of this, the Exchange would like to clarify that the Enhanced Director Amendments & Miscellaneous Changes take effect as follows:
 - (a) Listed corporations must publish their Directors' Fit and Proper Policy on their websites² by 1 July 2022.
 - (b) Listed corporations with market capitalisation of RM2 billion and above as at 31 December 2021 must have at least 1 woman director³ on their boards by 1 September 2022. The rest of the other listed corporations must have at least 1 woman director on their boards by 1 June 2023.

- (c) Listed corporations must comply with the amended definition of independent director⁴ where all long serving independent directors of more than 12 years must resign or be redesignated, and other consequential amendments⁵, by 1 June 2023.
