Dear Sir/Madam, BURSA MALAYSIA SECURITIES BERHAD (the "EXCHANGE") INTRODUCTION OF THE EXCHANGE'S NEW LISTING INFORMATION NETWORK SYSTEM ("NEW BURSA LINK")

Further to our letters dated 8 January 2015, 6 February 2015 and 18 February 2015 in relation to the above, please take note of the following:

1) Successful Connectivity Test

All Bursa LINK users are required to ensure successful connectivity of the New Bursa LINK system by performing a connectivity test between 16 March 2015 to 3 April 2015. After 3 April 2015, the New Bursa LINK system will not be available to users until Go-Live date. As such, LINK users who have attended the briefing sessions are required to perform successful connectivity test during the following period and time:

In order to experience a smooth and successful connectivity test, LINK users are advised to refrain from undertaking the connectivity test within the window period of 12.30pm to 1.30pm.
