The intended use of the Instruments' Profile template is to provide issuers with a standard disclosure format on the salient terms and conditions of an instrument listed on the Exchange. The issuers of the respective instruments shall be the main users of the template.

In this connection, the issuers are required to disseminate the Instruments' Profile via the Bursa LINK prior to the listing of the instruments. Please also be informed that the instrument's specific stock name and code should be used in the header of the template instead of the mother / underlying shares.
