PURPOSE OF THE DOCUMENT

This document outlines a high-level test script for the new Bursa LINK connectivity testing.

<u>SCOPE</u>

External users (Listed Issuer, External Company Secretaries and Investment Banks/Adviser) should be able to login, create and submit the announcement and/or online application via the new Bursa LINK.

For this exercise, users are required to undertake the following:-

- 1. Login first time and change password.
- Creation and submission of one type of announcement i.e. General Announcement ("GA") by all users.
- 3. External Company Secretaries and Investment Banks/Advisers are also required to create and submit one type of Online Application ("OA").

Note:

Users are to note that the provided URL is solely for connectivity test purposes. Information in certain types of announcements may not be complete as this is a test environment.
