	New provision.	25.04C(2)	"ISSB Negotiated Transaction" means a securities selling and buying transaction entered into between an Approved Supplier and an Approved User in accordance with the ISSBNT Model and the transaction is facilitated by the Clearing House in accordance with the Rules.
	New provision.	25.04C(2)	"ISSBNT Model" means the prevailing ISSBNT model endorsed by the Shariah Advisory Council of Securities Commission Malaysia.
