1. HALF DAY MORNING TRADING SESSION ON THURSDAY, 16 JULY 2015

1.1 Bursa Malaysia Derivatives will be opened for half-day morning trading session on 16 July 2015.

1.2 Reference to Business Day

However, where references to 'Business Day' are in relation to non-trading matters, 'Business Day' will be read as one (1) business day ending at the close of business of the Exchange on 16 July 2015.

2. EXCHANGE HOLIDAYS FOR HARI RAYA AIDILFITRI

Bursa Malaysia Derivatives market will be closed for trading on *Friday, 17 July 2015*. Bursa Malaysia Derivatives will resume business on *Monday, 20 July 2015*.

Should Monday, 20 July 2015 be declared as a holiday by the Malaysian government, Bursa Malaysia Derivatives will resume business on *Tuesday*, *21 July 2015*.
