1. HALF DAY TRADING SESSION ON THURSDAY, 14 JUNE 2018

1.1 Bursa Malaysia Derivatives Berhad ("**Bursa Malaysia Derivatives**") will be opened for trading only for the morning trading session on Thursday, 14 June 2018 in conjunction with the Hari Raya Aidilfitri holidays. There will be no trading in the afternoon session.
