Participants are hereby informed of the following:

1. HALF-DAY TRADING SESSION ON MONDAY, 4 FEBRUARY 2019

1.1 Bursa Malaysia Derivatives Berhad ("Bursa Malaysia Derivatives") will be opened for trading only for the morning trading session on Monday, 4 February 2019 in conjunction with the Chinese New Year holidays. There will be no trading in the afternoon session.
