## **BUSINESS CONTINUITY PLAN (BCP) SIMULATION EXERCISE ON 15 AUGUST 2020**

Reference is made to the Trading Participant Circular 15/2020 pertaining to the same subject that was issued on 29 May 2020. The Exchange would like to confirm that the BCP Simulation Exercise will proceed as scheduled on Saturday, **15 August 2020**.

CME Globex production trading platform will be made available for Trading Participants (TPs) to conduct the simulation on their own Disaster Recovery (DR) facilities to evaluate the readiness of their organization's BCP in the event of a failure to the trading facilities at their main site.

TPs are to make the necessary arrangements with their respective order management system vendors for participation in the upcoming exercise.
