Participants are hereby informed of the following:

1. HALF-DAY TRADING SESSION ON FRIDAY, 21 APRIL 2023

Bursa Malaysia Derivatives Berhad (“Bursa Malaysia Derivatives”) will be opened for trading for the morning session only on Friday, 21 April 2023 in conjunction with the Hari Raya Aidilfitri holidays. There will be no trading in the afternoon session.
