BUSINESS CONTINUITY PLAN ("BCP") SIMULATION EXERCISE ON 13 MAY 2023

Please be informed that the CME Globex production trading platform will be made available for Trading Participants ("TPs") on Saturday, 13 May 2023 for TPs to conduct simulation exercise on their own Disaster Recovery ("DR") facilities to evaluate readiness of their organisation's BCP if there is a failure to the trading facilities at their main site. Participation in this exercise is mandatory for all TPs unless they have conducted their live BCP test in 2023 or TPs who have their main site and DR site operating simultaneously on day-to-day basis.

TPs are to make the necessary arrangements with their respective order management system vendors for participation in this upcoming exercise.
