BURSA MALAYSIA CELEBRATES ACHIEVEMENTS IN THE CAPITAL MARKET AT THE BURSA EXCELLENCE AWARDS 2023

Kuala Lumpur, 29 April 2024 – Bursa Malaysia Berhad ("Bursa Malaysia" or the "Exchange") recently hosted the Bursa Excellence Awards 2023 at The St. Regis, Kuala Lumpur, with luminaries of Malaysia's capital market and broking community. In this 11th edition, the awards event combined the prestigious Bursa Excellence Awards with the Retail Investor Campaign and the Mirror, Learn & Trade ("MLT") Analyst Awards, for a comprehensive recognition of outstanding performance across the Malaysian capital market.

The 2023 awards ceremony honoured the achievements of brokers and market intermediaries across the Securities, Derivatives and Islamic markets, awarding 53 accolades in 23 categories. Additionally, 76 winners of the Retail Investor Campaign, and 6 analysts of the MLT programme¹ were also recognised at the event.

In his welcoming speech at the event, Tan Sri Abdul Wahid Omar mentioned that the broking community's pursuit of excellence and unwavering dedication, working hand-in-hand with Bursa Malaysia, have been instrumental in helping shape Malaysia's capital market. "The Bursa Excellence Awards stands as a beacon of outstanding achievements in Malaysia's capital market. We are pleased to present the Awards in recognition of the synergistic efforts and exceptional accomplishments of our broking community that drive the upward momentum of the capital market," Tan Sri Abdul Wahid said.

In 2023, Bursa Malaysia maintained strong market performance with an Average Daily Trading Value (ADV) of RM2.06 billion, exhibiting resilience and robustness above prepandemic levels. The year also welcomed 32 Initial Public Offerings (IPOs) raising RM3.6 billion, to bring total IPO market capitalisation to RM13.6 billion. A higher number of 1,497 structured warrants were also issued in 2023. Meanwhile, the Average Daily Contract (ADC) for the Derivatives Market T+1 Night trading saw an increase of 3.1% in 2023.

On the Shariah equities trading front, in 2023, a new Islamic Participating Organisation was onboarded to facilitate Islamic stockbroking services, the Islamic Securities Selling and Buying – Negotiated Transaction (ISSBNT) Framework was enhanced, and there was a slight (1.6% year-on-year) increase in Shariah market capitalisation, contributed by increase in the number of Shariah-compliant public listed companies (PLCs) which stood at 82% of the total.

Datuk Muhamad Umar Swift, Chief Executive Officer of Bursa Malaysia, added, "The theme of 2023's awards, "Growth to Excellence: Redefining the Market's Future" reinforces our drive to grow our investor base while enhancing market resilience and inclusivity. Bursa Malaysia continues to collaborate with our broker partners and the broader market participants to meet the needs of corporate issuers, while ensuring that Malaysia's capital market is an appealing choice for investors."
