- (1) *Guidance Note 1
Classification of Applicants and Listed Corporations***

We refer to the amended Guidance Note 1 of the ACE LR issued on 8 May 2009, which will come into effect on 3 August 2009 ("**GN1**").

Pursuant to paragraph 2.1 of GN1, Bursa Malaysia Securities Berhad ("**Bursa Securities**") will prescribe a list of sectors which an applicant or a listed corporation will be classified into. In this connection, we enclose the list of Sectors prescribed by Bursa Securities, for your attention. As stated in GN1, this list may be varied by Bursa Securities at any time and is available on our website at <http://www.bursamalaysia.com>.

- (2) *Undertaking Letters To Comply with Listing Requirements***

We refer to undertaking letters by listed corporations, directors, advisers and any other relevant persons ("**Existing Undertakings**"), which have been executed and submitted to Bursa Securities pursuant to the Listing Requirements for the MESDAQ Market ("**MMLR**").

Please note that notwithstanding the change of name from "MESDAQ" to "ACE", the ACE LR are the MMLR with amendments as envisaged under the Existing Undertakings. As such, the Existing Undertakings will remain effective and binding.

- (3) *Questions & Answers***

We are pleased to enclose the Questions & Answers in relation to the ACE LR and the transitional arrangements in relation to the application of the ACE LR, for your reference. We hope the Questions & Answers will facilitate and aid listed corporations' compliance with the ACE LR.

**CLASSIFICATION OF APPLICANTS OR LISTED CORPORATIONS
FOR THE ACE MARKET**

Sector Classified	Definition
Consumer Products	Companies manufacture materials or components into new products for consumer use
Construction	Companies engage in constructing any form of structure including roads & railroads
Finance	Companies that provide services in activities of obtaining and redistributing funds, in the form of deposits by Central Banks and other monetary institutions, insurance and other activities auxiliary to financial intermediation
Hotels	Companies that provide hospitality services in the form of accommodation, meals and drinks
Industrial Products	Companies manufacture materials or components into new products for industrial use
Mining	Companies engage in exploration extraction, dressing and beneficiating of minerals
Plantations	Companies engage in the cultivation, planting and/or replanting of crops. The processing of agricultural products in factories on farms and plantations is also included if it is not feasible to report separately this activity from production of crops
Properties	Companies invest directly or indirectly in real estate through management or ownership
Trading/Services	Companies engage in distribution of products and provision of services other than financial services, e.g. banking and insurance
Technology	Companies that provide information technology solutions
