AMENDMENTS TO THE BEST PRACTICE NO. 7.16-001 (BEST PRACTICES IN THE ISLAMIC STOCKBROKING SERVICES UNDERTAKEN BY PARTICIPATING ORGANISATIONS) ("BEST PRACTICES FOR ISLAMIC POS")

1. AMENDMENTS TO THE BEST PRACTICES FOR ISLAMIC POS

- 1.1 Following the recent development and enhancement of products and services available in the securities market, Bursa Malaysia Securities Berhad ("Exchange") has updated the Best Practices for Islamic POs to reflect the best practices in relation to the newly introduced and enhanced products and services.
- 1.2 The salient amendments to the Best Practices for Islamic POs are as follows:
 - (a) included a guidance on Shariah discretionary trading. A new Section F sets out, among others, the provisions on the creation of a Shariah Discretionary Account and the applicable Shariah contracts between an Islamic PO and its Client for the provision of Shariah discretionary trading services i.e. wakalah, mudarabah and musharakah;
 - (b) included for consistency, a guidance in relation to Islamic Securities Selling & Buying Negotiated Transaction ("ISSBNT"), which reflects the model set out in the Frequently Asked Questions on ISSBNT available on the Exchange's website; and
 - (c) amended the existing terms used in the Best Practices for Islamic POs for clarity and introduced new defined terms consequential to items (a) and (b) above.
- 1.3 The amended Best Practices for Islamic POs is set out in **Annexure 1**.

2.0 EFFECTIVE DATE

2.1 The amendments to the Best Practices for Islamic POs take effect on 16 May 2022.
