TERMS OF CONDITIONS OF PARTICIPATION IN BURSA BULL CHARGE 2023 (“BBC2023”)

The BBC2023 is organised by Bursa Malaysia Berhad (“Bursa Malaysia”) and comprises the following events:

- a) Race event which consists of: i) CEO run category (1.5km); and ii) Corporate and Bursa Young Investor Club (BYIC) category (5.0km)
- b) Best Dressed Competition
- c) Bursa Bull Dance
- d) Net Zero Games Booth
- e) Sponsors’ Booth

By participating in BBC2023, participants agree to be bound by these terms and conditions (“Terms and Conditions”).

For the purposes of these Terms and Conditions:

1. Bursa Malaysia shall be referred to as “Organiser”.
2. Bursa Bull Charge 2023 shall be referred to as “Event”.
3. Corporations participating in the Event shall be referred to as “Companies”.
4. Individual participants in the teams of the Companies and individuals who are members of the Bursa Young Investor Club shall be referred to as “Race Participants”.
5. Participants in the Best Dressed Competition shall be referred to as “Best Dressed Participants”.
6. Participants in the Bursa Bull Dance shall be referred to as “Bull Dance Participants”.
7. Participants in the Net Zero Games Booth shall be referred to as “Games Participants”.
8. All participants of the event shall collectively be referred to as “Participants”.

A. RACE

Participation criteria

1. The Event is open to all Companies and students who are members of the Bursa Young Investor Club (BYIC) in Malaysia.
2. Participation of Companies in the Event must be via teams organised by Companies to represent the Companies in the Event. No individual participation is allowed for participation by Companies. Each team must consist of at least one (1) female Participant.

Race Registration

1. Completion and submission of the official registration form confirms the Companies and Race Participants’ agreement to abide by these Terms and Conditions.
2. Companies and Race Participants from BYIC must select the relevant category(ies) for their participation. Substitution and changing of categories is NOT allowed after submission of registration.
3. Companies and Race Participants from BYIC shall provide true, accurate, current and complete information in the registration of the Race Participants. The Organiser may contact the Race Participants from time to time by email. Any notice sent to the email address registered with the Organiser shall be deemed to be received by the Race Participants. If any information provided in relation to a Race Participant or the Race Participants is untrue, inaccurate, not current or incomplete, or if the Organiser has ground to suspect that any information provided is untrue,

inaccurate, not current or incomplete, the Organiser may at any time suspend, revoke, cancel or terminate the participation of such Race Participant or the participation of the Company in the Event. The Organiser will not entertain changes to the Event categories after confirmation of registration or be in any way responsible for any disputes arising from incomplete or inaccurate details in the registration form.

4. Registration for the race is only confirmed when payment of the fee is made. There will be no fee refund in any circumstances including but not limited to subsequent non-participation by the Company or any Race Participant for whatever reason, if the Event is cancelled for reasons or occurrence of incidents that are beyond the control of the Organiser and which renders it impossible or unsafe to hold the Event.
4. Companies and Race Participants are strictly not allowed to transfer their participation registration to another party.
5. The Organiser also reserves the right at its absolute discretion to limit and/or refuse entry of a Race Participant or disqualify a Race Participant from the Event if the Organiser is of the opinion that such Race Participant is acting in any manner which is against the interest of the Organiser and/or the Event or which is in violation of these Terms and Conditions and/or any rules or regulations of the Event or suspected of foul play or fraud.

Race Kit Entitlements

1. Companies must obtain the consent of the individual Race Participants in a Company's team to their race kit being picked up by a representative and send a representative to pick up the race kits for all the teams registered by the Company. Companies are responsible for picking up their own race kits and the Organiser reserves the right to refuse race kit collections by an individual Race Participant in a Company's team.
2. All representatives from the Companies and individual Race Participants from BYIC must collect their race kits on the race kits collection day which will be notified in the Organiser's social media page.
3. The Organiser shall not be liable for any loss or inconvenience due to any inability to collect the race entry packs. The Organiser may extend the collection time at the Organiser discretion and on a goodwill basis only. For the avoidance of doubt, the Organiser is not obliged to extend the collection time or to ensure that the Race Participants receive their race kits. At all times, it is the responsibility of each Company to collect their race kits during the collection period specified by the Organiser. The Organiser reserves the right to dispose of or to redistribute race kits that are not collected during the collection period.
4. Race kits will include the race bib, race t-shirt and other goodies. The Organiser will provide the race t-shirt based on the specified size stated in the registration form. If any of the specific sizes are unavailable, the Organiser has the right to replace such sizes with a different size.

Race Management and Participation

1. Whilst every reasonable precaution will be taken by the Organiser to ensure the safety of the Race Participants, the Organiser will not be responsible or held liable for any injury or death howsoever arising from training for or during participation in the race. Race Participants acknowledge and agree that they participate in the Event and run at their own risk and are therefore, Race Participants are strongly encouraged to undergo a medical examination and or consult a medical practitioner on their health and safety prior to registration for participation and before the Event.
2. Race Participants must wear the running bib with the assigned number on his/her chest at all times during the race. Race Participants consent to having their location and timing

tracked in the race by an NFC tracker on the running bib to assess their individual and where applicable, team timing. Race Participants who are found to not be wearing the bib number will be taken off the Event's race route by security officials.

3. Race Participants must at all times follow the Event's respective run routes, race times, the direction of security officials, traffic management officials, event officials and any enforcement officers.
4. Race Participants must retire from the Event immediately if required to do so by any of the Event's officials, medical staff, race director, race secretariat or security officers.
5. No pets or any form of wheel-run objects of transport e.g. In-line skates, prams, push chairs, shoes with rollers, etc. are allowed during the race.
6. The Organiser reserves the right to amend the Event's race routes as it deems fit whether for the safety of the participants/ or to prevent any potential hazards in the running of the Event or otherwise, at any time. In such event, reasonable efforts will be made to inform the Race Participants prior to the date of the Event.
7. The Organiser reserves the right to delay the commencement of the race in the event of heavy rain or thunderstorm or extreme weather condition or any catastrophic or natural disaster. Should the condition or circumstance causing delay persists after delay, the Organiser reserves the right to cancel the race without any liability or refund.
8. Road closures along the race route will be in place during the race and will be lifted after completion of the race. The route will not be guarded by road marshals before the start of the race and after the closure time. Race Participants are not allowed to commence the race (flag off) before the actual start time or to remain on the route after the closure time. If a Race Participant proceeds to run before the start of the race and/or after the closure time, it will be at the Race Participant's own risk and the timing will not be considered valid for the purposes of the Event.
9. The Organiser reserves the right to use any photograph (including those of participants), motion pictures, recordings or any other media records of the Event taken before, during and after the Event, for any legitimate purpose including commercial advertising and distribution to sponsors.
10. The Organiser is not responsible for any loss, injury or claims from using sponsored and non-sponsored products or services in this run.

Selection of winners

1. The following are the categories within each of the 2 race categories of the Event (i.e. CEO run category (1.5km) and Corporate and Bursa Young Investor Club (BYIC) category (5.0km):
 - a) Best Individual Runner (Female)
 - b) Best Individual Runner (Male)
 - c) Best Veteran Runner (Female)
 - d) Best Veteran Runner (Male)
 - e) Fastest Team
2. Race Participants will be ranked in each applicable category according to their run timing. In the case of team participation by Companies, the average of the top 3 timings in a team (e.g. if Race Participants A, B, C has the shortest timings in a team with Race Participants A, B, C, D, only the timings of 3 Race Participants A, B, C are counted and averaged to assess the timing of the team) will be considered.

3. The Organiser's decision on selection of winners shall be final and binding. Any dispute in relation to the winners, timing of a Race Participant and prizes strictly will not be entertained.
4. Race Participants who are selected as winners in any of the abovementioned categories are deemed to have consented to their name, bib number and name of organisation read, published or posted to the general public.

Finisher Medals and Certificates

1. Finisher medals will be distributed at the finish line of the race to all Race Participants.
2. E-certificates for participation in the race will be issued within 14 days after the Event day. The e-certificates will be e-mailed to all Race Participants.

B. BEST DRESSED COMPETITION

Eligibility

The Best Dressed Competition is open to all Race Participants ("Best Dressed Participants").

Competition Period

The Best Dressed Competition will commence at 6:00am on the day of the Event and end at 8.30pm on the same day. All entries must be submitted during this period to be considered.

How to enter

1. On the event day, Best Dressed Participants must take a photo of themselves or their team at the Event's photo wall.
2. Best Dressed Participants must ensure that their whole outfit is visible in the photo. If a Best Dressed Participant's outfit is not visible in the photo, such photo will be disqualified.
3. Best Dressed Participants must upload their photos in the relevant categories (Best Dressed Individual Man, Best Dressed Individual Woman, Best Dressed Team) in a drive to that will be provided during the Event. The QR code will be provided by the Event's photo wall.

Judging criteria

1. Entries will be judged based on creativity, effort and authenticity and uniformity and in the case of Best Dressed Team category, company representation. The decision of the judging panel will be final and binding. The Organiser reserves the right to amend the judging criteria as and when they deem fit.
2. The Organiser reserves the right to disqualify any entry that violates these Terms and Conditions or contains inappropriate content.

Prizes

Prizes will be awarded to Best Dressed Participants awarded with the highest scores in all the categories based on the judging criteria. Prizes are non-transferable and cannot be exchanged for cash or an alternative prize.

Announcement of winners

Winners will be announced during the Event at the prize-giving ceremony.

C. BURSA BULL DANCE

Eligibility and participation criteria

1. The Bursa Bull Dance is a team-based competition and is open to all Companies.
2. Only 5 teams that register their intention to participate by the deadline specified by the Organiser, will be considered for participation on a first come, first serve basis.
3. All participants in a team MUST be employees of the participating Company and must be aged 18 years old and above ("Bull Dance Participants").
4. The minimum and maximum number of Bull Dance Participants allowed in for each team is 6 and 10 people respectively.

Dance requirements

1. Bull Dance Participants are required to perform a dance with aerobic movements to their own music selection. The choreography should incorporate any dance movements such as hip-hop, Soca, samba, salsa, merengue, and mambo. "Lunges in the air", pyramid formations and acrobatic moves are STRICTLY prohibited and may result in the team being DISQUALIFIED from participating in the Bursa Bull Dance or winning a prize.
2. The duration of each performance by Bull Dance Participants MUST be for a minimum duration of 3 minutes and shall not exceed 5 minutes.

Prizes and selection of winners

1. Prizes for Bursa Bull Dance are as follows: -

Winners	Prize
Winner	RM3,000
1 st runner up	RM2,000
2 nd runner up	RM1,000
Consolation prize	RM500

2. A panel of judges will assess the team performance based on the following:

a	Choreography	0.5 to 4 points
b	Technical (Execution)	0.5 to 4 points
c	Costumes	0.5 to 2 points

3. Teams will be ranked based on the combined scores of 2(a), 2(b) and 2(c) for each team and winners selected according to the highest scores. The judges' decision is final, and binding and no correspondence, disputes or appeals will be entertained.

D. NET ZERO GAMES BOOTH

Eligibility

Participation in the Net Zero Games Booth (the "Games") is open to individuals of all ages ("Games Participants"). Games Participants under the age of 18 must have parental or guardian consent to participate.

Games rules and conduct

Games Participants must adhere to the rules and regulations of each Game. Any inappropriate behaviour including but not limited to unsportsmanlike behaviour or conduct, cheating, or violation of rules or these Terms and Conditions will result in disqualification from the Games.

Games safety and liability

Games Participants acknowledge and agree that they engage and participate in the Games at their own risk. The Organiser and Games booth operators shall not be liable for any injuries, damages, or losses sustained during participation by the Games Participation and arising out of a Games Participant's act or omission.

Prizes

Prizes may be awarded to Games Participants based on their performance in the Games. Prizes are non-transferable and cannot be exchanged for cash or an alternative prize.

Modification or discontinuation of Games

The Organiser reserves the right, at its sole discretion, to modify, suspend, or discontinue the Games at any time, with or without notice, for any reason.

E. GENERAL

1. The Organiser may at any time, and it deems fit or necessary, modify or substitute any of these Terms and Conditions and any other rules and regulations of the Event without prior notice. If there is ambiguity in any of these Terms and Conditions or rules and regulations of the Event, the Organiser will be the authority to interpret the affected provision. The decision of the Organiser shall be final and binding. Any update, modifications or changes on the Terms and Conditions or any other rules and regulations of the Event will be notified on the official website (unless otherwise stated) and will take effect from the date of notification on the official website.
2. The Organiser reserves the right to change the date, times and venue of the Event or the mechanics of the Event (including but not limited to race categories, race routes, selection of winners) or the activities within the Event. The Organiser may postpone or cancel the Event at any time in which case the Organiser will use reasonable efforts to inform the Participants. In the event of any postponement or cancellation, there shall be no refund of fees and the Organiser shall not be liable to the Participants or any third party for any loss or inconvenience caused. Any updates on the event including any changes to the terms will be posted on the event official website. It is the responsibility of the participants to keep abreast with such updates and changes. The Organiser shall not be liable for any loss or convenience caused.
3. By participating in the Event, all Participants agree that the Organiser may take photographs and recordings (video and/or audio) of the Participants during the Event. The Organiser shall own the intellectual property rights to the photographs and recordings captured during the Event and may use the said photographs and recordings for promotional and/or marketing purposes.
4. These Terms and Conditions shall be governed by and construed in accordance with the laws of Malaysia.

F. PERSONAL DATA PROTECTION

By registering to participate and participating in the Event, Participants explicitly consent to the processing of their personal information provided to the Organiser including but not limited to any

information on health, for the purposes of the Event and where relevant, the purposes described in the Personal Data Notice on the Bursa Malaysia website. To read the Personal Data Notice, click [here](#)

G. ASSUMPTION OF RISKS, DISCLAIMER, WAIVER AND RELEASES OF LIABILITY

1. Participants, in particular Race Participants acknowledge and agree that the Event carries certain inherent danger and risks may or may not be readily foreseeable including without limitations to personal injury, damage to property or death. Participants are fully aware of the risks and hazards relating to participation in the Event and agrees that their participation in the Event is voluntarily in spite of potential risks and danger. Each and every Race Participant warrants that he/she is in good physical condition, has sufficient preparations and can safely participate in the Event.
2. In consideration for being permitted to participate in the Event, Participants hereby waive, release and forever discharge, for himself, his heirs, executors, administrators and legal representatives, any and all rights and/or claims which Participants may have against the Organiser, its officers, directors, employees, consultants, agents and Event sponsors for any and all damages and/or claims which may be sustained by him directly or indirectly arising out of his participation in the Event (including the application of emergency or medical services at the Event). Further, Participants covenant not to take any action against the Organisers, its officers, directors, employees, consultants, agents and Event sponsors for any and all damages and/or claims which may be sustained by the Participant directly or indirectly arising out of his participation in the Event. This release and discharge include, but is not limited to, claims for property damage, economic loss, breach of contract, lost wages, contribution indemnity, other indemnities, punitive damages, or any other legally recognisable claim arising out of the Participants' participation in the Event (including all legal costs associated with such claims).
3. Participants hereby indemnify the Organisers, its directors, officers, employees and sponsors against any and all claims, lawsuits and causes of action whatsoever or howsoever arising and brought against them by any third party as a result of the Participants' actions and/or participation in the Event, including without limitation, the violation of any laws or regulations by Participants or the Participants' breach of these Terms and Conditions or any rules or regulations of the Event.
4. The Organiser and its employees, directors, officers, agents, sponsors, partners and supporters accept no responsibility for any liability or loss whether direct or indirect arising out of participation in the Event. Participants waive and release the Organiser and its employees, directors, officers, agents, sponsors, partners and supporters from any claims or liabilities of any kind arising in connection with participation in the Event even though that liability may arise out of negligence or carelessness of any such party.
